



**NOTIFICATION**

S.O..... In exercise of the powers conferred by sub-section (2) of the section 11 of the Indian Medical Council Act, 1956(102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act, due to change of affiliating University namely:-

In the said First Schedule before "Devi Ahilya Vishwa Vidyalaya" and entries thereto "Madhya Pradesh Medical Science University, Jabalpur" shall be added and against "Madhya Pradesh Medical Science University, Jabalpur" under the heading 'Recognized Medical Qualification' [hereinafter referred to as column (2)] after the last entry and entry relating thereto under the heading 'Abbreviation for Registration'[ hereinafter referred to as column (3)], the following shall be inserted namely:-



"Doctor of Medicine (Gastroenterology)"	DM (Gastroenterology)
"Doctor of Medicine (Neurology)"	DM (Neurology)
"Magistrar Chirurgiae (Neuro Surgery)"	M.Ch (Neuro Surgery)
"Magistrar Chirurgiae (Paediatric Surgery)"	M.Ch (Paediatric Surgery)
"Magistrar Chirurgiae (Urology/Genito-Urinary Surgery)"	M.Ch (Urology/Genito-Urinary Surgery)
"Doctor of Medicine (Reproductive Medicine / Magistrar Chirurgiae (Reproductive Medicine & Surgery)"	D.M.(Reproductive Medicine / M.Ch(Reproductive Medicine & Surgery
"Doctor of Medicine (Nephrology)"	D.M.(Nephrology)
"Doctor of Medicine (Oncology)"	D.M. (Oncology)
"Magistrar Chirurgiae (Surgical Oncology)"	M.Ch (Surgical Oncology)

The above PG Degree course shall be a recognized medical qualification when granted by "Madhya Pradesh Medical Science University, Jabalpur" in respect of students being trained at Sri Aurobindo Medical College and PG Institute, Indore on or after October 2017).

Note: 1. The recognition so granted to a Postgraduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

2. The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Postgraduate Course.
