
Sir,

I am directed to inform you that an assessment to assess the physical and the other teaching facilities available for Recognition/Approval of Sri Aurobindo Medical College & Postgraduate Institute, Indore, M.P. under Devi Ahilya Vishwavidyalaya, Indore for the award of MBBS degree against the increased intake i.e. 100 to 150 seats u/s 11(2) of the IMC Act, 1956 was carried out by the Council assessors on 21<sup>st</sup> & 22<sup>nd</sup> February, 2019. The assessment report (21<sup>st</sup> & 22<sup>nd</sup> February, 2019) alongwith the summary/observations of the Members of the Undergraduate Expert Group appointed by the Board of Governors was considered by the Board of Governors in supersession of Medical Council of India and decided to recommend to the Central Government for recognition/approval of Sri Aurobindo Medical College & Postgraduate Institute, Indore, M.P. for the award of MBBS degree granted by Devi Ahilya Vishwavidyalaya, Indore against the increased intake i.e. from 100 to 150 seats u/s 11(2) of the IMC Act, 1956.

The Board of Governors in supersession of Medical Council of India further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

In view of above, you are requested to issue necessary notification at the earliest recognizing Sri Aurobindo Medical College & Postgraduate Institute, Indore, M.P. for the award of MBBS degree when granted on or after March, 2016 by Devi Ahilya Vishwavidyalaya, Indore against the increased intake i.e. from 100 to 150 seats.
